



# Please Vote "YES" on Issue 17!

A Message from Brian Thomas, President/CEO

Summit DD is one of the most essential points of connectivity between UDS and the individuals we serve. They

provide a large share of the funding for programs that support more than 5,000 children and adults with disabilities in Summit County. They link the individuals to the programs and providers of the consumer's choice, and Summit DD also monitors those activities to assure safe and healthy conditions and practices.

Issue 17, supporting Summit
DD, will appear on ballots in
Summit County in November.
This is the first time in six
years that voters are asked
to approve a levy to renew
this vital financial support for
citizens with developmental disabilities.

Your "YES" vote will go toward replacing the same 4.5 "mills" that have been in place since 2005. (A mill is a fraction of a penny on every \$1,000 of property value.) This is structured into the real estate taxes paid by property owners. If the levy passes, the bottom-line increase to the taxpayer means \$3.58 more per month for every \$100,000 in property value.

As an informed voter, you may be concerned about having the same share of taxation on your property continue, when property values in Summit County will jump significantly in 2024. That is why it is very important for you to know

that the millage will apply to the current (2023) values, and it will remain at the 2023 level for the next six years.

One of the complexities of the funding is that these local monies absolutely must be available in order to access the offsetting federal Medicaid funds that are managed by the State of Ohio. Thus, in a very real sense, the access to federal, state and local funding for disability services is in the hands of voters at the ballot box.

Please help us keep these invaluable services in place... If you are reading this, chances are you are well aware of the need for this funding. You may know first-hand how people's daily lives are impacted by the funded programs.

With your "YES" vote, UDS will continue to provide day programs and transportation to well over 200 adults. We will continue to provide recreational sports to more than 400 youth and adults. We will continue to reach scores of children, from newborns on up, through our Toy Resource Center. The individuals we serve will continue to explore activities throughout the community, make friends, share experiences, and possibly volunteer or prepare for a job in the community.

Please help us keep these invaluable services in place for so many valued Summit County neighbors and friends. Vote "YES" on Issue 17!



Vincent died in November 2020 due to injuries sustained in a tragic accident while riding his bicycle, leaving the community of Hudson grieving his loss. As a result, Vincent's family created an event to remember and celebrate his young life and the impact he made on others while here.

"We believe that helping others is written on the human heart," says Lindsay Baran, Vincent's mother. "Our goal is to make this easy for people and instill a love of service early on."

This year several volunteers from Seton Catholic School in Hudson spent a beautiful fall afternoon at UDS playing games with participants in our adult day programs and helping to assemble, clean and organize toys in the Toy & Resource Center. This is the second consecutive year
